It's that time of year again, February 15 through April 30. Know the burning laws!

VIRGINIA'S 4 P.M. BURN LAW STARTS FEBRUARY 15

Late winter and early spring are particularly high-risk times for fires due to dry conditions, winds and dormant vegetation. Each year from February 15 to April 30, Virginia enforces a 4 p.m. Burn Law to reduce the risk of wildfires. However, even outside this timeframe when the risk is predictable, the Virginia Department of Forestry uses a fire danger rating system to evaluate conditions – including weather, fuel moisture, and wind speed – that impact the likeliness of wildfires.

Virginia's 4 p.m. Burn Law

This law prohibits open-air burning before 4 p.m. if the fire is within 300 feet of woodland or dry grass. After 4 p.m., anyone burning must remain vigilant, have proper firefighting tools on hand, and ensure the fire is completely out before leaving the area.

Daily Fire Danger Rating System

Ranging from Low to Extreme, this rating system helps citizens make informed decisions about burning debris or conducting controlled burns. See the readiness classes to the right and before lighting any fire, always check the daily rating on the <u>Department of Forestry</u> website to determine if conditions are safe.

Controlled Burn Fire Safety Tips

By following guidelines and respecting fire laws, we can help prevent wildfires and protect homes, forests, and wildlife. Stay safe and burn responsibly by:

- · Checking the fire danger rating before burning
- Avoiding burning on windy or dry days
- Always having water and tools nearby to control the fire
- · Never leaving a fire unattended
- Calling 911 immediately if a fire spreads out of control



Readiness Class Day Definitions

The image of the sign above is a reflection of the daily evaluation of conditions. The specific readiness class day measures used by the Virginia Department of Forestry are defined below:

Class 1 - LOW Fire Danger
No appreciable fire activity.
Fires do not ignite readily.
Fires that do start spread slowly and often burn irregularly.

Class 2 – MODERATE Fire Danger
Occasional fire activity.
Fires can start from most accidental causes; number of
starts generally low.
Fires burn at low to moderate rates; heavy fuel
concentrations may burn hot.
Fires usually controlled in initial attack phase.

Class 3 – HIGH Fire Danger
Normal fire season activity.
Fires start easily from most causes.
Fires burn at moderate to fast rates; control can be difficult if control action is not started promptly.

Class 4 - VERY HIGH Fire Danger
Above normal fire activity and/or conditions.
Fires start readily and spread rapidly.
Control of head fires may be difficult to impossible until fire
behavior factors change.

Class 5 – EXTREME Fire Danger
Severe fire conditions.

Fires often escape initial attack. Direct attack of fires
virtually impossible.

Fire behavior is erratic; resistance to control is high. Fires
are not usually controlled until burning conditions subside.

Potential for fire disaster is high.

Multiple fire starts are likely.


Supervisors toughen penalties for roaming dogs

Dog owners who allow their canines to roam could be subject to a criminal conviction under tough new rules approved by the board of supervisors on Tuesday night.

The board held a public hearing and voted unanimously to amend county code to address ongoing issues with dogs running at large. A dog is considered running at large when it's "roaming or running off the property of its owner or custodian and not under its owner's or custodian's immediate control," according to state and county code.

Under the new rules, allowing a dog to run at large "shall constitute" a Class 4 misdemeanor on the first offense. A second violation within one year of a conviction for the first violation "shall constitute" a Class 2 misdemeanor. A third or subsequent violation within two years of conviction for the second or subsequent violation "shall constitute" a Class 1 misdemeanor.

A Class 4 misdemeanor is punishable by a maximum \$250 fine. A Class 2 misdemeanor is punishable by up to six months in jail and/or up to a \$1,000 fine while a Class 1 misdemeanor is punishable by up to a year in jail and/or a maximum \$2,500 fine, per state code.
